Don,

The evidence from the 2nd Judicial District Attorney's office continues to show a marked relationship between low-income high-density housing and crime levels in those areas. I've sent several of these to you, the first on Aug 20, each showing approximately the same magnitude of crime levels: 3 or 4 items in the Four Hills area, 11 - 12 pages of items in the Singing Arrow area. In this month's update from the DA, of the 3 items shown in the Four Hills area, only one is actually in Four Hills. One item. There are 12 pages of items in the Singing Arrow area.

The only time I've had a response from you directly was Aug 20 when, in response to my initial email to you on this subject, you directed Michael Horanburg to look into this. On November 11, I asked if you would consider getting personally involved as the developers might respond more readily to a sitting City Council member than to his staff or to me, and I inquired into your personal thoughts on this proposed project.

If the developers ever responded to your office on this matter, I'm unaware of that.

I again respectfully ask that you consider getting directly involved and that you share your personal thoughts on this matter.
