Minutes of the FHVA Board Meeting of May 16, 2023

1. Call to Order

President Andrew Lipman opened this hybrid meeting at 6:32 p.m.

2. Approval of Agenda: Andrew asked for a motion to approve the agenda. Julia made the motion to approve the agenda, James made the second and the motion unanimously passed.

3. Introduction of Guests:

Ann Harris Davidson (FHV resident), attended to listen and offer comments.

4. Approval of the FHVA Board Meeting Minutes of the March 21 and April 19, 2023 Monthly Meetings:

We had no quorum at the April meeting, thus no vote could be taken to approve the March minutes. Julia made a motion that we approve the minutes for both the March and April meetings. 5. Reports, as needed from Officers and Board Members

5.A. President, Andrew Lipman

5A.1. IDO Updates. The updates to the IDO are moving along. The HOAs and neighborhood associations within the District 9 East Gateway Coalition are pushing back on some components of the IDO. Councilor Grout is hosting an Open House tonight to discuss the implications of the new proposals. Andrew will meet with her policy analyst, Rachel Miller, tomorrow to get up to speed on the information at tonight's Open House.

5.B. Vice President, Herb Wright

Absent due to Work Obligations. Herb has been in frequent communication with Andrew as he has been rewriting our Bylaws to make them compliant with the new IDO. He will present them to us at our special meeting on June 27.

5.C. Treasurer, Linda Martinez

The checking account has a balance of \$8971.86. Revenue received January 1 to May 13, 2023, was \$1094.10 for membership dues and \$1700.00 for advertising, for a total of \$2794.10.

Bills paid this period were \$4,471.88, to include \$2,245.88 for the Annual General Meeting, \$167.85 for the prizes for the Annual Holiday Light Contest, \$16.47 for supplies, \$1,037.24 for publication of The Chronicle, \$187.43 to renew Weebly, \$803 for Insurance, and \$14.01 for MailChimp

The FHVA's current money market account balance is \$23,327.95. Interest accrued was a grand total of \$0.77.

Linda has also received checks from Disney, as they offered a donation to FHVA since they were filming in our neighborhood. Andrew stated that after the new Bylaws are written that we need to make a concerted effort to seek out more donations.

5.D. Secretary, Jennifer Lopez

5.D.1. Good Neighbor Article. Jennifer has chosen a person for the next article and is working on securing an interview time.

5.E. Membership Director, Julia Vertrees

- **5.E.1. Membership Numbers**. Membership total is approximately 273, with 51 double-member families to the best of Julia's count. For 21 of the double-member families each member has their own listing in the master database, and for 10 of the double-member families the family has a joint, single-family listing. Since Julia's last report we have gained one new member.
- **5.E.2. MailChimp.** While Julia was on vacation Andrew was able to successfully send several email blasts using our MailChimp account. This accomplished one of the goals of the MailChimp purchase! Our free introductory month has ended. As a reminder our account type allows for 500 email contacts and 5000 sends per month. We sent 5 email blasts in our first month to 233 contacts using 1165 of our 'sends'. If we do not exceed these limits MailChimp estimates our bill for May will be \$14.01. Starting in May, we have 237 members/families who have given us an email address, 3 of which unsubscribed in the first month of use. MailChimp provides analytics on our email blasts with info such as how many opened the mail (we have been running between 65-75%). If interested, Julia can provide the board with copies of the reports.
- **5.E.3. Facebook.** Julia now has owner access to the FHVA Facebook page but she has not had time to learn how to link it to MailChimp.

5.F. Education and Youth Affairs. Jerry Gallegos

- **5.F.1. Networking.** Jerry and APS officials met at Manzano High School to discuss options for families in our district, specifically for STEM programs.
- **5.F.2 Transfers and Student Distribution.** Jerry wonders where Four Hills Village children are attending schools. Are they leaving the traditional schools to attend charter schools and private schools? Ann Harris Davidson suggests that we go door to door to survey families with children as to their school choices so that when we speak to APS officials, we will speak with knowledge.

5.G.1. Visits. Over the last 30 days, our website had 274 unique visits and 535 page views.
