Minutes of the FHVA Board Meeting of December 19, 2023

Hybrid meeting – held at Singing Arrow Community Center & via Zoom 6:30 – 8:00 p.m.

1. Call to Order

President Andrew Lipman opened this hybrid meeting at 6:30 p.m.

2. Approval of Agenda

Andrew asked for a motion to approve the agenda with the deletion of Troy Hill, as he has resigned. Herb made a motion to approve the agenda with the deletion and Linda made the second. The motion carried.

2. Introduction of Guests

Ayoni Oyenuga and Erin Burch. They are from Consensus Planning and are here to discuss the Proposed Stagecoach Trailhead Project. The project includes an approximately 600' gravel road that will go beyond the gate at the Stagecoach Trailhead. Five to ten parking places will be included at the end of the gravel road. The gate will be locked every night by APD or OS Conservation officers, or by residents who are willing to help be responsible for the nightly closing of the gate. All visitors and day campers would be required to leave the area each night. They informed us that a Facilitated Virtual Meeting will be held on January 4, 2024 and sent around a sheet on which interested parties could sign up.

Colleen McRoberts. She is the Superintendent of the City of Albuquerque Open Space Division and is here to discuss the Proposed Stagecoach Trailhead Project. She states that no decisions have been made regarding the project. They are in an information gathering phase. Rusty informed Colleen that the Nichols Court Case prohibits the gravel road from being wider than 15'.

Alfred Lorber and David Johnny. They are FHV residents whose homes are both adjacent to the Stagecoach Trailhead Project. They both wish to gain and share information regarding the above project. Mr. Lorber and Mr. Johnny do not want the road extended into the interior of the Open Space. They are worried that folks would camp overnight. Mr. Lorber states that they have had no input into this project even thought his home is adjacent to the proposed gate and road extension. He has already had contact with victims of crime perpetrated by people camping in that area and does not want a road that would invite more people to camp and partake in illegal activities adjacent to our neighborhood. Andrew sees that much\ more discussion regarding this project is desired from FHV residents. A special meeting specific to this topic will be scheduled so more discussion can be had.

Steve McCampbell, Tim Gallegos (via Zoom), and Carmil Surrit. These gentlemen have all placed their names on the ballot to be FHVA officers or directors for 2024.

Sara Valentine. She is FHV resident who wishes to be kept abreast of how the Board operates.

City Councilor Renee Grout: She joins our meetings as her schedule allows to gain and share information regarding policies that effect FHV.

4. Approval of the FHVA Board Meeting Minutes of the November 21, 2023 Monthly Meeting.

5.C.1. Account Balances. The checking account has a balance of \$8,077.93. Revenue received January 1 to December 18, 2023, was \$6,849.35, which included \$2,999.43 for membership dues, \$3,150.00 for advertising, and a \$700 contribution from Disney because they were filming in our neighborhood.

Bills paid January 1 to December 18, 2023 were \$9,421.04, to include \$2245.88 for the Annual General Meeting, \$167.85 for the prizes for the Annual Holiday Light Contest, \$16.47 for supplies, \$4,010.30 for the Chronicle, \$187.43 for Weebly Renewal, \$803 for insurance, \$111.96 for Mail Chimp, \$503.69 for Survey Monkey, \$645.75 for the Shred Event, and \$248 for the Annual PO Box Fee.

5.C.2. Money Market Account. The FHVA's current money market account balance is \$23,417.42. Interest accrued through November 30, 2023 was a grand total of \$90.34. As President, Andrew needs to accompany Linda to the credit union to initiate the CDs before his term expires.
