MEMBERSHIP

Welcome to Four Hills Village and to the Four Hills Village Association! The early goals of this neighborhood's association mirror today's goals of our membership 50 years later. We continue to build this community through maintaining the quality of life for residents, caring for the upkeep of the local environment, and supporting the interests of neighbors. We are so happy you're here! Please join us and add to our neighborhood's story.

All residents of Four Hills Village (property owners and also renters) aged 18 years or older are eligible to be members of the Four Hills Village Association.

Active, dues-paid membership is on a yearly basis, running for the calendar year from January 1 to December 31. **Please pay your membership Dues in the Month of December, by December 31** for the following calendar year's membership. If you move to Four Hills Village and join FHVA during the 4th Quarter (Oct – Dec), your paid membership extends for the following year.

The annual FHVA membership fee is \$25 for up to a 2-member household. Membership information is listed under ARTICLE IV – Membership, of the FHVA Bylaws and may be updated/changed by member vote at the January general meeting. Paid FHVA membership confers (at minimum) the following rights and privileges:

- Receipt of the Quarterly Newsletter, The Chronicle, via emailed pdf.
- Receipt of the Annual Membership Directory.
- Eligibility to participate in the FHVA Annual (January) General Meeting.
- Eligibility to be nominated (self or otherwise) for an FHVA Board member position (Officer or Director) in the annual Board elections, with the election held by mail-in vote towards the end of each calendar year (for members to serve in the following calendar year), as well as eligibility to vote for candidates for those FHVA Board positions.
- Observational attendance at monthly FHVA Board meetings, with the opportunity to speak, briefly, towards the start of a Board meeting (given advance notice to the president).
